PRIZES WILL BE AWARDED TO TOP 3 CHALLENGERS**

CHILI PEPPER CHALLENGE RULES:

1. All participants must be 18 years of age or older.
2. All contestants will complete and sign the waiver of liability.
3. Contestants will compete against each other.
4. The object is to finish each pepper (of varying degrees of heat).
5. **ABSOLUTELY NO SWALLOWING THE PEPPER WHOLE. YOU HAVE TO CHEW IT!**
6. Each contestant will be supplied a beverage.
7. This drink will have to last the duration of the event.
8. Contestants must stop eating at the ending signal.
9. Judges will be on hand to assure adherence to contest rules.
10. Starting with the mildest pepper, you will have a designated amount of time to finish each one.
11. If you haven't finished eating the entire pepper in the allotted time you will be eliminated.
12. If you show any signs of illness you will be eliminated.
13. In each round, the number of peppers (in each heat category), will be increased by one whole pepper.
14. The contest will continue until the last person is standing (not literally).
15. Top 3 places will win a prize. To determine 1st, 2nd and 3rd place you have to consume one more round of peppers over the previous person dropped out.

Acknowledgment of Risks and Waiver of Liability: Contestant acknowledges that there are risks of personal injury, illness and possible loss of life, and risks of damage to or loss of personal property, which may result from participating in this contest.
